Report UWSS/12/23 dated October 13th, 2023 re: Rectifying Resolution to Confirm Decisions and Actions by UWSS Inc. Interim Board of Directors

The CEO welcomes everyone to the meeting. He notes that he is going to allow our legal representative, William Willis, explain the rectifying resolution.

William Willis explains what actions have occurred so far with the four (4) interim directors of the board. He notes that even though the first four (4) directors have approved certain policies and created several resolutions, now, with a full board, the new board needs to approve all of the items in order to continue forward.

The Manager reads the resolution in full.

There were several questions from the directors including where the directors could obtain copies of the policies to review. There was a discussion as to why both the Joint Board of Management and the Board of Directors was running consecutively. The Manager explains that this is necessary until assets have been transferred and the budget has been approved.

William Willis explains that a package will be sent to the municipalities within the next week or so with the intention that January 1, 2024 there will be a final transition over to the new Board of Directors. The old board will then need to complete the year end for 2022.

There is then a discussion regarding due diligence and William Willis clarifies that is there is an item that is controversial it will need to be brought to the attention of both boards for the time being. The Manager notes that he does not envision anything of significance that will need to be brought forward.

Finally, there was a small discussion regarding a few housekeeping items, such as email, acronyms, etc.
